These Terms of Use (the "Terms") are a binding contract between you and HAPPY VENTURES PUBLIC BENEFIT CORPORATION ("Happy Ventures, PBC," "we" and "us"). Your use of the Services in any way means that you agree to all of these Terms, and these Terms will remain in effect while you use the Services. These Terms include the provisions in this document as well as those in the Privacy Policy, Copyright Dispute Policy and any other relevant policies. Your use of or participation in certain Services may also be subject to additional policies, rules and/or conditions ("Additional Terms"), which are incorporated herein by reference, and you understand and agree that by using or participating in any such Services, you agree to also comply with these Additional Terms.

Please read these Terms carefully. They cover important information about Services provided to you. These Terms include information about <u>future changes to these Terms</u>, <u>limitations of liability</u>, <u>a class action waiver and resolution of disputes by arbitration instead of in court</u>. PLEASE NOTE THAT YOUR USE OF AND ACCESS TO OUR SERVICES ARE SUBJECT TO THE FOLLOWING TERMS; IF YOU DO NOT AGREE TO ALL OF THE FOLLOWING, YOU MAY NOT USE OR ACCESS THE SERVICES IN ANY MANNER.

ARBITRATION NOTICE AND CLASS ACTION WAIVER: EXCEPT FOR CERTAIN TYPES OF DISPUTES DESCRIBED IN THE <u>ARBITRATION AGREEMENT SECTION BELOW</u>, YOU AGREE THAT DISPUTES BETWEEN YOU AND US WILL BE RESOLVED BY BINDING, INDIVIDUAL ARBITRATION AND YOU WAIVE YOUR RIGHT TO PARTICIPATE IN A CLASS ACTION LAWSUIT OR CLASS-WIDE ARBITRATION.

Will these Terms ever change?

We are constantly trying to improve our Services, so these Terms may need to change along with our Services. We reserve the right to change the Terms at any time, but if we do, we will place a notice on our site located at www.ppeconnect.org, send you an email, and/or notify you by some other means.

If you don't agree with the new Terms, you are free to reject them; unfortunately, that means you will no longer be able to use the Services. If you use the Services in any way after a change to the Terms is effective, that means you agree to all of the changes.

Except for changes by us as described here, no other amendment or modification of these Terms will be effective unless in writing and signed by both you and us.

What about my privacy?

Happy Ventures, PBC takes the privacy of its users very seriously and will endeavor to keep information private beyond what is shared on the website and to facilitate PPE donations.

Children's Online Privacy Protection Act

The Children's Online Privacy Protection Act ("COPPA") requires that online service providers obtain parental consent before they knowingly collect personally identifiable information online from children who are under thirteen (13). We do not knowingly collect or solicit personally identifiable information from children under thirteen (13); if you are a child under thirteen (13), please do not attempt to register for or otherwise use the Services or send us any personal information. If we learn we have collected personal information from a child under thirteen (13), we will delete that information as quickly as possible. If you believe that a child under thirteen (13) may have provided us personal information, please contact us at support@ppeconnect.org.

What are the basics of using Happy Ventures, PBC?

You may be required to sign up for an account, select a password and user name ("Happy Ventures, PBC User ID"), and provide us with certain information or data, such as your contact information. You promise to provide us with accurate, complete, and updated registration information about yourself. You may not select as your Happy Ventures, PBC User ID a name that you do not have the right to use, or another person's name with the intent to impersonate that person. You may not transfer your account to anyone else without our prior written permission.

You represent and warrant that you are an individual of legal age to form a binding contract (or if not, you've received your parent's or guardian's permission to use the Services and have gotten your parent or guardian to agree to these Terms on your behalf).

You will only use the Services for your own internal, personal, non-commercial use, and not on behalf of or for the benefit of any third party. You will comply with all laws that apply to you, your use of the Services, and your actions and omissions that relate to the Services (for example, Donors must comply with all laws that relate to the Donor Goods (as those terms are defined below)). If your use of the Services is prohibited by applicable laws, then you aren't authorized to use the Services. We can't and won't be responsible for your using the Services in a way that breaks the law.

You will not share your Happy Ventures, PBC User ID, account or password with anyone, and you must protect the security of your Happy Ventures, PBC User ID, account, password and any other access tools or credentials. You're responsible for any activity associated with your Happy Ventures, PBC User ID and account.

Connecting Donors and Healthcare Providers

Happy Ventures, PBC connects those providing certain goods ("Donors") and those looking to acquire those goods ("Healthcare Providers"). When we use the word "you" in these Terms, it refers to any user, regardless of whether he or she is a Donor or Healthcare Provider, while if we use one of those specific terms, it only applies to that category of user.

Before receiving goods from any Donor ("Donor Goods"), Healthcare Providers are responsible for making their own determinations that the Donor Goods are suitable. Happy Ventures, PBC is only responsible for connecting Donors and Healthcare Providers, and can't and won't be responsible for the Donor Goods, or making sure that Donor Goods are up to a certain standard of quality. Happy Ventures, PBC similarly can't and won't be responsible for ensuring that information (including credentials) a Healthcare Provider or Donor provides about himself or herself or about the Donor Goods he or she is offering is accurate or up-to-date. We don't control the actions of any Healthcare Provider or Donor, and Donors aren't our employees.

Happy Ventures, PBC DOES NOT DIRECTLY OFFER THE DONOR GOODS. YOU HEREBY ACKNOWLEDGE THAT Happy Ventures, PBC DOES NOT SUPERVISE, DIRECT, CONTROL OR MONITOR THE DONOR GOODS AND EXPRESSLY DISCLAIMS ANY RESPONSIBILITY AND LIABILITY FOR THE DONOR GOODS, INCLUDING BUT NOT LIMITED TO ANY WARRANTY OR CONDITION OF QUALITY OR FITNESS FOR A PARTICULAR PURPOSE, OR COMPLIANCE WITH ANY LAW, REGULATION, OR CODE. THE DONOR GOODS MAY NOT BE MEDICAL DEVICES, OR MAY NOT BE INTENDED TO BE USED AS MEDICAL DEVICES. FURTHERMORE, THE DONOR GOODS MAY NOT BE REGULATED NOR APPROVED BY THE U.S. FOOD AND DRUG ADMINISTRATION, AND MAY NOT BE DESIGNED TO DETECT OR PREVENT CAUSES OF ANY MEDICAL CONDITION. YOU ACKNOWLEDGE, UNDERSTAND AND AGREE THAT YOUR USE OF THE SERVICES, CONTENT AND DONOR GOODS IS ENTIRELY AT YOUR OWN RISK.

Healthcare Providers and Donors must not enter into separate agreements outside of Happy Ventures, PBC relating to Donor Goods ("Outside Agreements"). If you do enter into any Outside Agreement we may terminate your Happy Ventures, PBC account, and you acknowledge that Happy Ventures, PBC is not a party to and isn't responsible for enforcing any Outside Agreement.

No Medical Advice; Not for Emergencies

Happy Ventures, PBC does not offer medical advice or diagnoses, or engage in the practice of medicine. Our Services are not intended to be a substitute for professional medical advice, diagnosis, or treatment and are offered for informational and communicative purposes only. The Services are not intended to be, and must not be taken to be, the practice of medicine, nursing, pharmacy or other healthcare advice by Happy Ventures, PBC.

Photo and Video Release.

In order to increase the numbers of donors and healthcare providers on the site, Happy Ventures, PBC may from time to time use photos and videos that users have provided us in our marketing communications. By using this service, you are granting permission to Happy Ventures, PBC to use photographs and/or videos of you, which you have uploaded to the website or otherwise sent in to the company or its employees.

What about messaging?

As part of the Services, you may receive communications through the Services, including messages that Happy Ventures, PBC sends you (for example, via email). When signing up for the Services, you will receive a welcome message and instructions on how to stop receiving messages. By signing up for the Services and providing us with your wireless number, you confirm that you want Happy Ventures, PBC to send you information regarding your account or transactions with us, which may include Happy Ventures, PBC using automated dialing technology to text you at the wireless number you provided, and you agree to receive communications from Happy Ventures, PBC, and you represent and warrant that each person you register for the Services or for whom you provide a wireless phone number has consented to receive communications from Happy Ventures, PBC. You agree to indemnify and hold Happy Ventures, PBC harmless from and against any and all claims, liabilities, damages (actual and consequential), losses and expenses (including attorneys' fees) arising from or in any way related to your breach of the foregoing.

Are there restrictions in how I can use the Services?

You represent, warrant, and agree that you will not contribute any Content or User Submission (each of those terms is defined below) or otherwise use the Services or interact with the Services in a manner that:

- (a) infringes or violates the intellectual property rights or any other rights of anyone else (including Happy Ventures, PBC);

No Donor may collect any information from or relating to Healthcare Providers ("Healthcare Provider Information"), whether via the Services, in the course of offering Donor Goods, or otherwise, beyond

what is necessary to offer the Donor Goods for the applicable Healthcare Provider from or about whom such Healthcare Provider Information was collected. Donors also must not use any Healthcare Provider Information beyond what is necessary to offer the Donor Goods for such applicable Healthcare Provider. Upon the conclusion of offering the Donor Goods to a Healthcare Provider (or otherwise upon the request of such Healthcare Provider or Happy Ventures, PBC), Donor must properly destroy all Healthcare Provider Information from or relating to such Healthcare Provider and make no further use of it whatsoever. Donors must collect, use, maintain, and transmit all Healthcare Provider Information in compliance with all applicable laws.

What are my rights in the Services?

The materials displayed or performed or available on or through the Services, including, but not limited to, text, graphics, data, articles, photos, images, illustrations, User Submissions (as defined below) and so forth (all of the foregoing, the "Content") are protected by copyright and/or other intellectual property laws. You promise to abide by all copyright notices, trademark rules, information, and restrictions contained in any Content you access through the Services, and you won't use, copy, reproduce, modify, translate, publish, broadcast, transmit, distribute, perform, upload, display, license, sell, commercialize or otherwise exploit for any purpose any Content not owned by you, (i) without the prior consent of the owner of that Content or (ii) in a way that violates someone else's (including Happy Ventures, PBC's) rights.

 - (a) A physical or electronic signature of a person authorized to act on behalf of the owner of the copyright that has been allegedly infringed;
 - (b) Identification of works or materials being infringed;
 - (c) Identification of the material that is claimed to be infringing including information regarding the location of the infringing materials that the copyright owner seeks to have removed, with sufficient detail so that Company is capable of finding and verifying its existence;
 - (d) Contact information about the notifier including address, telephone number and, if available, email address;
 - (e) A statement that the notifier has a good faith belief that the material identified in (1)(c) is not authorized by the copyright owner, its agent, or the law; and
 - (f) A statement made under penalty of perjury that the information provided is accurate and the notifying party is authorized to make the complaint on behalf of the copyright owner.
- (2) <u>Once Proper Bona Fide Infringement Notification is Received by the Designated Agent</u>. Upon receipt of a proper notice of copyright infringement, we reserve the right to:
 - (a) remove or disable access to the infringing material;
 - (b) notify the content provider who is accused of infringement that we have removed or disabled access to the applicable material; and
 - (c) terminate such content provider's access to the Services if he or she is a repeat offender.
- (3) <u>Procedure to Supply a Counter-Notice to the Designated Agent</u>. If a counter-notice is received by the Designated Agent, Company may, in its discretion, send a copy of the counter-notice to the original complaining party informing that person that Company may replace the removed material or cease disabling it in 10 business days. Unless the copyright owner files an action seeking a court order against the content provider accused of committing infringement, the removed material may be replaced or access to it restored in 10 to 14 business days or more after receipt of the counter-notice, at Company's discretion.

THE SERVICES AND CONTENT ARE PROVIDED BY Happy Ventures, PBC (AND ITS LICENSORS AND SUPPLIERS) ON AN "AS-IS" BASIS, WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, OR THAT USE OF THE SERVICES WILL BE UNINTERRUPTED OR ERROR-FREE. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.

Limitation of Liability. To the fullest extent allowed by applicable law, under no circumstances and under no legal theory (including, without limitation, tort, contract, strict liability, or otherwise) shall any of the happy ventures, PBC parties be liable to you or to any other person for (a) any indirect, special, incidental, punitive or consequential damages of any kind, including damages for lost profits, business interruption, loss of data, loss of goodwill, work stoppage, accuracy of results, or computer failure or malfunction, (b) any substitute goods, services or technology, (c) any amount, in the aggregate, in excess of the greater of (i) one-hundred (\$100) dollars or (ii) the amounts paid and/or payable by you to happy ventures, PBC in connection with the services in the twelve (12) month period preceding this applicable claim or (d) any matter beyond our reasonable control. Some states do not allow the exclusion or limitation of incidental or consequential or certain other damages, so the above limitation and exclusions may not apply to you.

<u>Indemnity</u>. You agree to indemnify and hold the Happy Ventures, PBC Parties harmless from and against any and all claims, liabilities, damages (actual and consequential), losses and expenses (including attorneys' fees) arising from or in any way related to any claims relating to (a) your use of the Services (including any actions taken by a third party using your account), and (b) your violation of these Terms.

<u>Assignment</u>. You may not assign, delegate or transfer these Terms or your rights or obligations hereunder, or your Services account, in any way (by operation of law or otherwise) without Happy Ventures, PBC's prior written consent. We may transfer, assign, or delegate these Terms and our rights and obligations without consent.

<u>Choice of Law</u>. These Terms are governed by and will be construed under the Federal Arbitration Act, applicable federal law, and the laws of the State of Delaware, without regard to the conflicts of laws provisions thereof.

<u>Arbitration Agreement</u>. Please read the following ARBITRATION AGREEMENT carefully because it requires you to arbitrate certain disputes and claims with Happy Ventures, PBC and limits the manner in which you can seek relief from Happy Ventures, PBC. Both you and Happy Ventures, PBC acknowledge and agree that for the purposes of any dispute arising out of or relating to the subject matter of these Terms, Happy Ventures, PBC's officers, directors, employees and independent contractors ("Personnel") are third-party beneficiaries of these Terms, and that upon your acceptance of these Terms, Personnel will have the right (and will be deemed to have accepted the right) to enforce these Terms against you as the third-party beneficiary hereof.

- (a) Arbitration Rules; Applicability of Arbitration Agreement. The parties shall use their best efforts to settle any dispute, claim, question, or disagreement arising out of or relating to the subject matter of these Terms directly through good-faith negotiations, which shall be a precondition to either party initiating arbitration. If such negotiations do not resolve the dispute, it shall be finally settled by binding arbitration in New Castle County, Delaware. The arbitration will proceed in the English language, in accordance with the JAMS Streamlined Arbitration Rules and Procedures (the "Rules") then in effect, by one commercial arbitrator with substantial experience in resolving intellectual property and commercial contract disputes. The arbitrator shall be selected from the appropriate list of JAMS arbitrators in accordance with such Rules. Judgment upon the award rendered by such arbitrator may be entered in any court of competent jurisdiction.
- (b) Costs of Arbitration. The Rules will govern payment of all arbitration fees. Happy Ventures, PBC will pay all arbitration fees for claims less than seventy-five thousand (\$75,000) dollars. Happy Ventures, PBC will not seek its attorneys' fees and costs in arbitration unless the arbitrator determines that your claim is frivolous.
- (c) Small Claims Court; Infringement. Either you or Happy Ventures, PBC may assert claims, if they qualify, in small claims court in New Castle County, Delaware or any United States county where you live or work. Furthermore, notwithstanding the foregoing obligation to arbitrate disputes, each party shall have the right to pursue injunctive or other equitable relief at any time, from any court of competent jurisdiction, to prevent the actual or threatened infringement, misappropriation or violation of a party's copyrights, trademarks, trade secrets, patents or other intellectual property rights.
- (d) Waiver of Jury Trial. YOU AND Happy Ventures, PBC WAIVE ANY CONSTITUTIONAL AND STATUTORY RIGHTS TO GO TO COURT AND HAVE A TRIAL IN FRONT OF A JUDGE OR JURY. You and Happy Ventures, PBC are instead choosing to have claims and disputes resolved by arbitration. Arbitration procedures are typically more limited, more efficient, and less costly than rules applicable in court and are subject to very limited review by a court. In any litigation between you and Happy Ventures, PBC over whether to vacate or enforce an arbitration award, YOU AND Happy Ventures, PBC WAIVE ALL RIGHTS TO A JURY TRIAL, and elect instead to have the dispute be resolved by a judge.
- (e) Waiver of Class or Consolidated Actions. ALL CLAIMS AND DISPUTES WITHIN THE SCOPE OF THIS ARBITRATION AGREEMENT MUST BE ARBITRATED OR LITIGATED ON AN INDIVIDUAL BASIS AND NOT ON A CLASS BASIS. CLAIMS OF MORE THAN ONE CUSTOMER OR USER CANNOT BE ARBITRATED OR LITIGATED JOINTLY OR CONSOLIDATED WITH THOSE OF ANY OTHER CUSTOMER OR USER. If however, this waiver of class or consolidated actions is deemed invalid or unenforceable, neither you nor Happy Ventures, PBC is entitled to arbitration; instead all claims and disputes will be resolved in a court as set forth in (g) below.

- (f) Opt-out. You have the right to opt out of the provisions of this Section by sending written notice of your decision to opt out to the following address: 7200 Wisconsin Ave., 5th floor, Bethesda MD 20814 postmarked within thirty (30) days of first accepting these Terms. You must include (i) your name and residence address, (ii) the email address and/or telephone number associated with your account, and (iii) a clear statement that you want to opt out of these Terms' arbitration agreement.
- (g) Exclusive Venue. If you send the opt-out notice in (f), and/or in any circumstances where the foregoing arbitration agreement permits either you or Happy Ventures, PBC to litigate any dispute arising out of or relating to the subject matter of these Terms in court, then the foregoing arbitration agreement will not apply to either party, and both you and Happy Ventures, PBC agree that any judicial proceeding (other than small claims actions) will be brought in the state or federal courts located in, respectively, New Castle County, Delaware, or the federal district in which that county falls.
- (h) Severability. If the prohibition against class actions and other claims brought on behalf of third parties contained above is found to be unenforceable, then all of the preceding language in this Arbitration Agreement section will be null and void. This arbitration agreement will survive the termination of your relationship with Happy Ventures, PBC.

Miscellaneous. You will be responsible for paying, withholding, filing, and reporting all taxes, duties, and other governmental assessments associated with your activity in connection with the Services, provided that the Happy Ventures, PBC may, in its sole discretion, do any of the foregoing on your behalf or for itself as it sees fit. The failure of either you or us to exercise, in any way, any right herein shall not be deemed a waiver of any further rights hereunder. If any provision of these Terms are found to be unenforceable or invalid, that provision will be limited or eliminated, to the minimum extent necessary, so that these Terms shall otherwise remain in full force and effect and enforceable. You and Happy Ventures, PBC agree that these Terms are the complete and exclusive statement of the mutual understanding between you and Happy Ventures, PBC, and that these Terms supersede and cancel all previous written and oral agreements, communications and other understandings relating to the subject matter of these Terms. You hereby acknowledge and agree that you are not an employee, agent, partner, or joint venture of Happy Ventures, PBC, and you do not have any authority of any kind to bind Happy Ventures, PBC in any respect whatsoever.

Except as expressly set forth in the section above regarding the arbitration agreement, you and Happy Ventures, PBC agree there are no third-party beneficiaries intended under these Terms.
